Dear Sir / Madam,

This is with reference to our letter dated July 7, 2025, wherein we had informed that the operations of the Manufacturing plant situated at Unit: Rajahmundry has been disrupted due to strike of workers called by the Workers Trade Unions w.e.f. July 6, 2025. The local administration is seized of the matter and the dispute is pending with the industrial tribunal for adjudication.

Therefore, the Management appealed to the workmen to call off the illegal strike as resorting to a strike during the pendency of proceedings before the Industrial Tribunal is prohibited. The strike is leading to loss of production and the workmen haven't resumed their duties as of July 10, 2025.

Considering the prevailing situation and with a view to safeguarding employees, plant and machinery, materials, and other assets, the Management has declared a lockout at the Rajahmundry unit effective from 8:00 AM on July 11, 2025. The lockout shall remain in force until further notice.

The details as required under Regulation 30 of SEBI (LODR) Regulations read with SEBI circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed as Annexure A.
